Situating “Situating Science”

The Social Sciences and Humanities Research Council of Canada's Strategic Knowledge Cluster, Situating Science: Cluster for the Humanist and Social Study of Science (www.situsci.ca), is pleased to announce new partnerships and new initiatives for Fall, 2011.

Since April, the Cluster has seen two Cluster workshops build upon national and international linkages. In April, Dr. Grace Shen, (York University) and Dr. Jahnvi Phalkey (King's College London), organized “Intersections: New Approaches to Science and Technology in 20th C. China and India”. The event brought together innovative China and India scholars to explore core problems in the history of modern science through the lens of China and India. It focused on using online collaboration sources to produce new, co-written papers at the intersection of scholars' expertise. In June, Dr. Alfred Moore (UBC) led a team in organizing “Scientific Authority Within Democratic Societies”, which brought North American and European scholars together to explore the different senses in which scientific and political authority are contested as well as the different democratic responses. Follow-up events and publications for each event are in the works.

Situating Science is Going to India!

Situating Science Director Dr. Gordon McOuat and team have been awarded a Social Sciences and Humanities Research Council of Canada (SSHRC) Aid to Research Workshops and Conferences grant to support a workshop in Manipal, India. Co-organized by Dr. Sundar Sarukkai, professor at the Manipal Centre for

Philosophy and Humanities in Manipal, India, “Sciences and Narratives of Nature: East and West” will mark the second stage in a multi-stage collaborative initiative between Canadian, Indian and Southeast Asian scholars in the field of Science and Technology Studies (STS). Following the successes of the “Circulating Knowledge: East and West” workshop held at the University of King's College in July, 2010, the India event will take a comparative approach to examine the rise of sciences and concepts of nature in the “East” and the “West”.

Dates for the event are currently set for December 12, 13 and 14th, 2011. Details, as they arise, will be posted on www.situsci.ca.

Call for Workshop Proposals 2011

Situating Science is soliciting workshop proposals for the timeframe of: Jan. 1, 2012 to March 31, 2013. Up to two Canadian workshops will be funded (up to \$10,000 each). Workshop topics should fall under one of the four themes of the Cluster. In accordance with our mandate, organizers are encouraged to seek inter-disciplinary participation (from within and/or outside the academy), and, where feasible, include a public component to their event. We also entertain proposals that include plans for an associated pedagogical component (e.g., 2-3 day “school”). The Cluster will provide financial and organizational support, with the expectation that organizers will leverage additional funding from partnering institutions. Please read the full Call online. 2011 President's Report

I am pleased to report that CSHPS has had a good year. This is due in large measure to the hard work of a truly outstanding group of officers, advisory board members, committee chairs, and committee members. I have been amazed by their willingness to answer emails promptly, brainstorm, problem-solve, and then move on to the next challenge. It is important to remember in this context that CSHPS, unlike some larger societies, depends entirely on volunteer labor. Later in this meeting, you will hear from several of these volunteers.

Before going any further, however, it is a great pleasure to ask our local hero and local organizer, Steve Turner, to stand up and be acknowledged. Steve has made our time at UNB comfortable and has kept us up-to-date with his postings of the CSHPS Daily News. His last act is to host a reception this evening at his house, to which we are all invited. I hope to see many of you there after the Drake Lecture and ask you to join me in thanking Steve for his efforts on our behalf.

There are several other bits of good news that bear mentioning. Adam Taves, a librarian at York University, has taken a leave to pursue a Master's degree in the Science and Technology Studies Program at York, for which Kenton Kroker is Grad Program Director. Kenton approached us about the possibility of having Adam's Major Research Project focus on setting up a CSHPS archive. (Whether this archive will eventually be housed in a library is a question that is separate from the research project itself.) The Executive Council enthusiastically endorsed the proposal, and Adam has been collecting old copies of *Communiqué* as well as other materials relevant to the history of CSHPS. He will also conduct interviews with some individuals who have played important roles in that history. If you have materials for Adam or any suggestions about people to be interviewed, please contact him directly: taves@yorku.ca. It is perhaps worth noting that Adam has now acquired copies of *Communiqué* for all but the earliest years.

Other good news: We have received \$2,685 from SSHRC, which will be used chiefly to subsidize grad student travel to this Congress. As Andrew Reynolds

will report later, we are in good shape financially and may be able to provide additional grad student support (on a one-time basis) this year.

We have also received (as in years past) funding from the National Research Council, which covers the cost of our membership in two divisions of the International Union for History and Philosophy of Science. One of these is the Division for History of Science and Technology; the other is the Division for Logic, Methodology and Philosophy of Science. To receive this money from NRC, we must complete an Annual Performance Review and receive a passing score. This can be challenging because the Review is designed for scientists rather than HPS-types. Lesley Cormack handled the Review this year, and we received a good score. We need to support Lesley's efforts on our behalf by keeping her apprised of all international activities in which CSHPS members are engaged. Please do not be shy about doing this; future NRC funding will depend on how good a case we can make for ourselves in any given year.

Our relationships to the organizations just mentioned are so complex that I have asked Lesley Cormack, in her capacity as First Vice-President, to provide us with an overview of these relationships.

[Lesley provided this information through a very helpful slide show. We then stopped to welcome two representatives from the Federation, who made a brief presentation and entertained questions.]

2011 Program Committee Report

The members of the 2011 Program committee were:

The committee received 79 individual abstracts and 1 session proposal. All papers were blind refereed. Sixty scholars presented in Fredericton in three parallel sessions. Of special note were a joint session with the Canadian Philosophical Association entitled "Science and Democracy," and a session on science and religion in memory of historian of science Margaret Osler.

The Stillman Drake Lecture presented by Bernard V. Lightman, Humanities Department and Program in Science & Technology Studies, York University, was the highlight of the meeting. Lightman's talk on "Science at the Metaphysical Society: Defining Knowledge in the 1870s," was attended by over 100 people. Engaging the history of important epistemological issues that have been at the center of debates in science and religion to this day, it was an extraordinary ending to the conference. Intellectually energized by the talk, many members of the audience then enjoyed kind hospitality and good food provided by our efficient local organizer, Steven Turner, at his home.

CFP: Interdisciplinary conference on early-modern science, Vancouver 2012

Paper and panel proposals are invited for *Scientiae*: a new interdisciplinary conference on early-modern science, to be held in Vancouver, B.C. (under the auspices of Simon Fraser University), April 26th-28th, 2012. The working assumption of the conference is that interdisciplinarity is not only an option, but a necessity, for the study of early-modern culture in its knowledge of the natural world. That is because period science is itself an interdisciplinary function, emerging from Biblical exegesis, advanced design, and literary humanitas; as well as from natural philosophy, alchemy, craft traditions, etc. By the same token, emergent science lends unique coherence to the gathered diversity of early-modern or Renaissance scholarship, when it is taken as an intellectual focal point. *Scientiae* offers a forum for scholars of the period's art and literature, as well as its intellectual history, to illuminate aspects of early-modern science in the latter's proper strangeness.

Topics and questions may include, but are by no means limited to:

- Protestantism and science: a decisive thesis?
- Nature and scripture: which interprets which?
- Integrating the Iberian empires – a recalibration, or a transformation?
- "Experimental" reading.
- Royal Society rhetoric: how well has it really been understood?
- Renaissance philosophy and the development of a "new" cosmology and anthropology.
- Paracelsianism, Neoplatonism, alchemy: where are we now?
- Invention and discovery: separable economies?
- Theological origins of the new science.
- Hermeneutic consequences of the Newtonian settlement.
- Scholastic scientia and postmodern theory.
- Early-modern information: is there any?
- Science and mimesis: reflection, or transformation?
- Early-modern literature and the new knowledge: friends, or foes?

The plenary speakers for *Scientiae* will be Mario Biagioli and Peter Harrison. Dr. Biagioli is Distinguished Professor of Law and Science and Technology Studies (STS) and Director of the Center for Innovation Studies at the University of California (Davis). Dr. Harrison is Andreas Idreos Professor of Science and Religion, Director of the Ian Ramsey Centre, and a Fellow of Harris Manchester College at Oxford University.

Other prominent speakers currently expected at *Scientiae* include: Amir Alexander, Stephen Clucas, Sven Dupré, Angus Gowland, Hakan Hakansson, Kevin Killeen, William Newman, Lawrence Principe, Claire Preston, and Jonathan Sawday. The conference co-organizers are James Dougal Fleming English, (SFU); and Steven Matthews (History, U of Minnesota at Duluth).

Seventh Joint Meeting of the BSHS, CSHPS, and HSS

10–13 July 2012, Philadelphia, Pennsylvania, USA

The seventh joint meeting of the British Society for the

History of Science, the Canadian Society for the History and Philosophy of Science, and the History of Science Society will take place in Philadelphia, Pennsylvania, USA from 10–13 July 2012. Previous successful meetings were in Oxford, England (2008); Halifax, Nova Scotia (2004); St Louis, Missouri (2000); Edinburgh, Scotland (1996); Toronto, Canada (1992); and Manchester, England (1988).

Unlike some 3-Society Meetings in the past, the 2012 conference has no stated theme; papers on all topics in the history of science are welcome. As 2012 marks the centennial of Isis, papers related to the history of both Isis and/or the discipline would be timely.

The Philadelphia Area Center for the History of Science (PACHS) is helping with the arrangements. Dorm room accommodations will be available at the University of Pennsylvania, and a small number of hotel rooms will be reserved for the conference (individuals will need to call the hotel directly or visit the HSS web site, www.hs-online.org, for reservations). The program will include parallel themed sessions, plenary lectures, education and outreach activities, and events at the American Philosophical Society, the Chemical Heritage Foundation, and the University of Pennsylvania. A more extensive social program is being developed by the local organizers. The conference schedule will offer delegates the opportunity to explore the many attractions to be found in the “City of Brotherly Love,” including Philadelphia’s extensive links to the history of science.

The Program Committee welcomes proposals for sessions or individual papers from researchers at all stages of their careers. Participation is in no way limited to members of the three organizing societies, but there will be a registration discount for members. Intending participants should also note that the usual HSS rules concerning presenting at successive conferences do not apply to this meeting.
